GOVERNING BODY COMMENTS

Mayor Myhre-Reported on the activities of the Stafford Township Police Department for the month of August. The Stafford Township Police Department will hold a presentation on the ABLE program on October 8th at 10:30 am at the Stafford Branch of the Ocean County Library. The Beach Haven West Phase II Water/ Sewer rehabilitation project has begun. On August 28th there was a fire at the Concession stand. Township staff has been working with the Joint Insurance Fund to get the stand up and running. Back road paving project is complete. Paving of Ocean Acres tennis court is underway. Additional paving to be done in the area of Newell avenue from Jennings to Jeannie those dates to be determined. Mayor Myhre provided the updates on inspections that have been done to the current Ocean County Library on Route 9. Stafford just recently was told that our Bond rating has been increased from current AA- to AA. This shows that the Township's long term outlook is very stable.

Councilman Williams-Reported on the activities of the Stafford Township Dial-A-Ride. The Green Team is currently working on new actions for 2021. The next Green Team meeting will be on Thursday October 7th at 5:30 pm via zoom. Councilman thanked all members of the Green Team members and volunteers for hosting the latest workshops.

Councilman Pfancook-Reported on the activities of the Stafford Township Public Works Department. He advised residents of yard cleanups. You can bag leaves and bring to the Township Yard. If you rake leaves to the curb they must stay on your property not in the roadway.

Councilman Krier-Reported on the Stafford Township Water and Sewer Utility Department for the month of August. The Township pumped over 87.7 million gallons to customers throughout the Township. Inspections and operations, daily work orders, water meter reading, service and maintenance to all vehicles.

Councilman Steadman-Reported that the Building and Zoning Department is running smoothly.

Councilman Henken-Reported on the activities of the Stafford Township Recreation Department. The Senior Advisory Committee held their meeting on Friday September 10th. The Committee welcomed four new members. They look forward to serving the local senior population. He announced the Fall Harvest Festival and Wine Festival October 9th and 10th from 12 to 5:00 pm.
